

INLAND VOLLEYBALL OFFICIALS ASSOCIATION 2010 Certification Calendar

The Inland Volleyball Officials Association must certify persons who wish to officiate interscholastic volleyball in the Riverside-San Bernardino area for member schools of the CIF-Southern Section.

- All veteran officials are required to attend 5 meetings of instruction. Officials would be well served to attend all listed meetings.
- New members (3 years or less) are required to attend 6 meetings of instruction. June 16, 2010 is mandatory for any official that is classified as a newbie.
- Veterans will be assigned to officiate scrimmages around the area on September 6, 7, or 8. This will count as two hours of instruction. In addition, officials who have less than 2 years of experience will be evaluated in game situations as assigned on September 6, 7, or 8.
- All officials will be required to referee at least two hours at a summer league tournament during the months of June, July or August. As soon as the dates are confirmed, it will be posted on the website.
- Note: All officials in IVOA must attend either the Oct 2 or the Oct 6 meeting and pass the written exam with a score of 80% or better to be eligible for playoffs.
